The U.S. Army Corps of Engineers is in the process of revising the Lake O' the Pines Master Plan's land use classifications. The master plan revision will guide the land and recreational management of the federally owned property that make up the lake and its shoreline for the next 25 years. Management activities include protecting natural and cultural resources, providing public land and water recreation, protecting the public, and ensuring reservoir and dam operations. Pertinent dam and reservoir information and a copy of the current land use map can be found on the reverse side of this form.
