concave nature of the manmade drainage allows for adequate hydrology to produce wetland conditions, and it appears the wetlands formed as a direct result of excavation in upland with the purpose of draining only uplands. Both wetlands are discontinuous and are separated by an upland area within the ditch. They are located outside of the 100-year floodplain, and there is no indication of a surface hydrologic connection between the wetlands and the nearest tributary (to Leon Creek) located approximately 5,000 feet west.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
