C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: FROM APAI PJD REPORT dated July 11, 2016

The dominant hydrological feature on the site is Peach Creek. The creek enters the western border of the site through a large box culvert under FM 2154 (Wellborn Road) and runs southeast across the west side of the property. The creek is classified as an intermittent stream by the USGS NHD and topographic map. During the site investigation, water was observed in most of the creek channel, but no flow was observed. The creek channel had riffle-pool-run complexes with the pools ranging from shallow (less than 6 inches) to greater than 3 feet in depth. The creek channel was slightly meandering and the bed substrate was mostly gravel and sand with some smooth bedrock stretches. Gravel and sand point bars were observed at meanders. The creek channel was slightly incised with sloping, mostly vegetated banks and creek bottom approximately 6 feet below top of bank. The width of Peach Creek at the OHWM varied along its reach across the property, but it was approximately 13.3 feet wide where the channel exits the southeast property boundary. Other sections ranged from about 24 feet wide in a braided riffle zone area across a stretch of bedrock to 6.5 feet wide in a straight run area. Figure A-11 in Appendix A of the PJD report shows the extent of Peach Creek on the site as observed in the field.

An upland stock pond sits approximately 850 feet to the northeast of Peach Creek on the investigation site. The pond is noted in the NHD and the NWI as a freshwater pond and is shown in historical aerials. The pond has no evidence of any defined inflow or outflow channels, and appears to have been developed on an upland area that is not within the 100-year floodplain of any waters of the U.S.

The topographic map also shows a dashed blue line that runs north to south through the western portion of the review area. This area was surveyed by APAI but no stream or other aquatic resource was identified.
