The Pier 121 Marina is operated on a lease to Safe Harbor Marinas (the Project Proponent) from the USACE. The purpose of the Proposed Project is to provide additional recreational facilities along the periphery of Lewisville Lake. The Proposed Project entails a comprehensive resort which includes a lakeside lodge, RV campground, RV storage, glamping sites, and a surf beach.
