Purpose of this Meeting

- Announce the availability of the draft revision of the Lavon Lake Master Plan and Environmental Assessment.
- Highlight changes proposed in the revised Master Plan compared to the previous 1972 version.
- Provide the public and stakeholders the opportunity to meet with USACE staff to review and discuss Master Plan recommendations.



The draft Master Plan with Environmental Assessment is available for 30-day public comment beginning May 5 through June 6, 2016.



Process Followed to Date

- Initial public meeting was held March 10, 2015 to announce preparation of a Master Plan Revision for Lavon Lake.
- Public and agency comments were received during a 30-day comment period from March 10 – April 10.
- All public and agency comments received were reviewed and considered in the preparation of the draft Master Plan Revision. (see Appendix H of the draft for comments and Government response)
- A Draft Environmental Assessment was prepared and is included in the Master Plan Revision as Appendix B.



Public/Agency Comments Summary

TOPIC	COMMENTS
Trails	Hike, bike, canoe and equestrian trails desired by many. Need management to reduce conflict. Trails across Corps lands needed to connect to Northeast Texas Trail. Need trails that connect to city streets. No motorized vehicles on trails.
Land Classifications	Broad consensus to protect open space. Several areas recommended for Environmentally Sensitive classification. Focus on low intensity uses.
Boat Ramps	Need year round access to ramps north and south. Extend length of ramps for low water conditions.
Leasing Parks	Consider leasing parks to City of Lucas. Do not transfer ownership or management to private interests. Preserve the Raptor Center.
Utility Corridors	Define utility corridors to preserve open space.
Campgrounds	Need 50 amp, water & sewer hookups. Campsite layout should be spacious, not crowded. More RV sites needed in Clear Lake Park.





Land Classification Definitions

Land Classification	Definition		
Project Operations	Those lands required for the dam, operations center, office, maintenance compound and other areas that are used solely for project operations		
High Density Recreation	Land developed for intensive recreational activities by the visiting public, including developed recreation areas and areas for marinas and related concessions, and resorts		
Multiple Resource Management	Recreation –Low Density: Activities such as hiking, primitive camping, wildlife observation, and hunting		
	Wildlife Management General: Fish and wildlife management activities		
	Vegetative Management: Management activities for the protection and development of a specific vegetative cover



Utility Corridors


- 13 Distinct Corridors Established
