The U.S. Army Corps of Engineers is in the process of revising the Whitney Lake Shoreline Management Plan. The purpose of the Shoreline Management Plan revision is to establish policies and provide guidelines for managing the shoreline (lakeshore) of Whitney Lake, Texas, for the protection of desirable environmental characteristics and for the restoration of shorelines where degradation has occurred. Public input is especially needed regarding revisions of shoreline allocation, which must compliment the 2016 Whitney Lake Master Plan.
