To recap BIG CHANGES:

1. Solicitations or Amendments that are created using the PIEE Solicitation Module **will** automatically transfer to SAM.gov for public viewing; however, any associated Attachment to that action **WILL NOT** transfer from PIEE to SAM.gov. **ATTACHMENTS MUST BE DOWNLOADED FROM PIEE.**
2. **ANYONE** can follow 4 Simple Steps to Search & Download Attachments from PIEE. Check out the fancy new flyer I just created. I even added a Quick Reference (QR) Code for the tech savvy who are mobile-friendly Remember—absolutely NO registration or log-in information is required to search or to download attachments from any "unrestricted" announcement posted using the PIEE Solicitation Module. This means you can share the flyer with Industry and across our entire PDT. Please try it so you can see how easy it is.
3. NOTE: To use the PIEE Solicitation Module to submit proposals/offers/bids, **ALL** users must be registered in PIEE and SAM.gov using the **same email address.**
