REQUESTER AND NON-FEDERAL SPONSOR: San Antonio River Authority (SARA).

LOCATION: The project is located on San Pedro Creek in Bexar County, in the City of San Antonio, Texas.

BACKGROUND: San Pedro Creek is part of the San Antonio Channel Improvement Project (SACIP), a U.S. Army Corps of Engineers (USACE) federally authorized Civil Works project, subject to Section 408, Section 404 of the Clean Water Act, and Section 106 of the National Historic Preservation Act (NHPA).

SOLICITATION OF COMMENTS: The USACE is soliciting comments from all parties having an interest in the undertaking's effect on historic property 41BX2359. Comments supporting, opposing, or identifying concerns with the documentation provided or the potential minimization and mitigation measures will be considered by the USACE to resolve adverse effects to historic properties. Additional measures or a combination of alternatives may also be considered. Issuance of this notice does not imply USACE endorsement of the draft report in its current form or of any minimization or mitigation measures proposed.
