USACE confirmed that the subject pond was excavated from upland between 1954 and 1964. All supporting information referenced within this document indicates that the pond is isolated, i.e., not hydrologically connected to a (a)(1)-(a)(4) water or non-jurisdictional water feature (e.g., ephemeral stream, swale, or erosional feature). The Corps has determined that the pond meets (b)(8) exclusion criteria.
