The 0.70-acre pond (PUB) was constructed prior to 1955 on a pre-existing steam channel that contributes to the San Antonio River. Presently, the pond is not hydrologically connected to the remaining stream channel. Water from the pond overflows from a spillway southward around a human-constructed dam / berm through approximately 200 feet of vegetated swale before becoming overland sheet flow for approximately 215 feet to the property boundary. Thus, there is at least 415 feet of non-JD waterway and overland sheet flow between the pond and the vegetated waterway / drainage that begins at the property boundary. Aerial imagery indicates that the upper reach of the pre-existing stream channel that begins at the property boundary has been channelized into a vegetated waterway / drainage that continues for approximately 1600 feet to Rancho Grande Road to the southwest. The use, degradation or destruction of the isolated pond would not affect interstate or foreign commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. # C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
