Explain: **The submittal is a hybrid AJD and PJD for an overall tract of land. The applicant has requested an AJD only for 15 separate and distinct water features (5 stream reaches, 1 wetland, and 9 ponds) which are either isolated or preamble waters and would not be jurisdictional. All potentially jurisdictional water features are contained in the PJD portion of the site. A site visit of 1/5/23 confirmed the status of the features subject to the AJD and confirmed the status of isolation of 5 ephemeral streams (1 with 1 adjacent wetland), 3 isolated ponds historically constructed on channel but are no longer connected to water features, and 6 upland stock tanks being preamble waters. Stream 12 loses its OHWM and sheet flows for a distance more than 180. Sheet flow is then captured in a preamble stock tank (Pond 1) that has no surface connection to waters. Stream 1 isolated by itself but is further isolated by the condition and effect of pond 1. Stream 18 terminates in a stock tank that has no outlet of surface connection to other**

waters. The OHWM with stream 18 is believed to be caused by the ponding of water in the stock tank. Stream 20, which has a wetland at its upper end, loses its OHWM and becomes sheet flow and has no surface connection to other waters for more than 1600 linear feet. Both the stream and wetland are isolated. Stream 27 loses its OHWM and becomes sheet flow for more than 300 feet to another water feature and is considered isolated. Stream 35 loses its OHWM and has sheet flow of more than 100 feet to another water and is isolated.

Ponds 1, 2 and 14 were all constructed on channels based on 1956 aerial imagery. However, the effects of historic ag production, hydrologic modifications by the ponds, and channel relocation in one circumstance, result in these ponds being isolated. There are no OHWMs or channels from these ponds downstream to other waters for 330, 400, and 250 feet respectively. Ponds 3, 4, 8, 10, 12, and 13 (which is located only on an historic upland ditch as shown on 1956 aerial), are all constructed in upland areas meet the definition of preamble waters.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
