Explain: **Three non-jurisdictional features were identified within the project area including one stock pond (Pond 1: 0.09 acre) and two excavated upland drainage ditches (Ditch 1: 1,394 LF, 0.27 acre; Ditch 2: 1,339 LF, 0.11 acre). Pond 1 is a stock pond that was visible in the earliest available historical data. The pond was observed to be leveed on all sides and does not connect to any potential waters of the U.S. Furthermore, the pond is located outside of any**

mapped floodplains. Pond 1 is not a natural pond or an imoundment of a water of the U.S.; therefore, because Pond 1 is an artificial stock pond that was excavated from uplands, it is not a regulated water as defined in paragraphs (a)(1)-(7) of the CWA 33 CFR 328.3. Ditch 1 was excavated through former uplands across the eastern side of the project area in 2008 when a residential neighborhood was constructed east of Roy Warren Parkway and Ditch 2 was excavated through former uplands in 2016 when a commercial driveway was constructed west of the project area. Both ditches were excavated from uplands, do not carry a relatively permanent flow of water, are located outside of any mapped floodplains, do not drain any wetlands, and were not carved from a natural stream feature; therefore, Ditch 1 and Ditch 2 are not regulated waters as defined in paragraphs (a)(1)-(7) of the CWA 33 CFR 328.3.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
