MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SWF-2025-00470.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Texas due to litigation.

1. SUMMARY OF CONCLUSIONS.

The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area). There are no aquatic features on the site.

3. REVIEW AREA.

The majority of the project is located in Upton County with the easternmost section of the project in neighboring Reagan County, Texas. (Upton County PID 5083). The review area 4 contains approximately 21.5257 acres and is surrounded by oil and gas infrastructure and intersects a wide gas pipeline right-of-way.

The site is located on the Sevenmile Corner NE USGS 7.5 Minute Topographic Map Quadrangle. The NWI illustrates a riverine feature and the NHD shows a flowline following the High Lonesome Draw. FEMA Floodplains have not been mapped for the Upton and Reagan Counties, Texas. Area 4 is comprised of Edwards Plateau riparian herbaceous vegetation, Rolling Plains mixed grass prairie, secondary succession mesquite shrubland and a small portion of Trans-Pecos desert wash shrubland.

A large, vegetated swale with no OHWM crosses the gas pipeline right-of-way from northwest to southeast and is in the location of the NWI riverine feature and blue-line feature on the topographic maps. Upon field inspection, the flowline was determined to be a vegetated swale in an area of lower elevation rather than a stream. There was no distinct OHWM observed. No aquatic features were found within the Review Area 4 site.

Figure 1A: Location Map

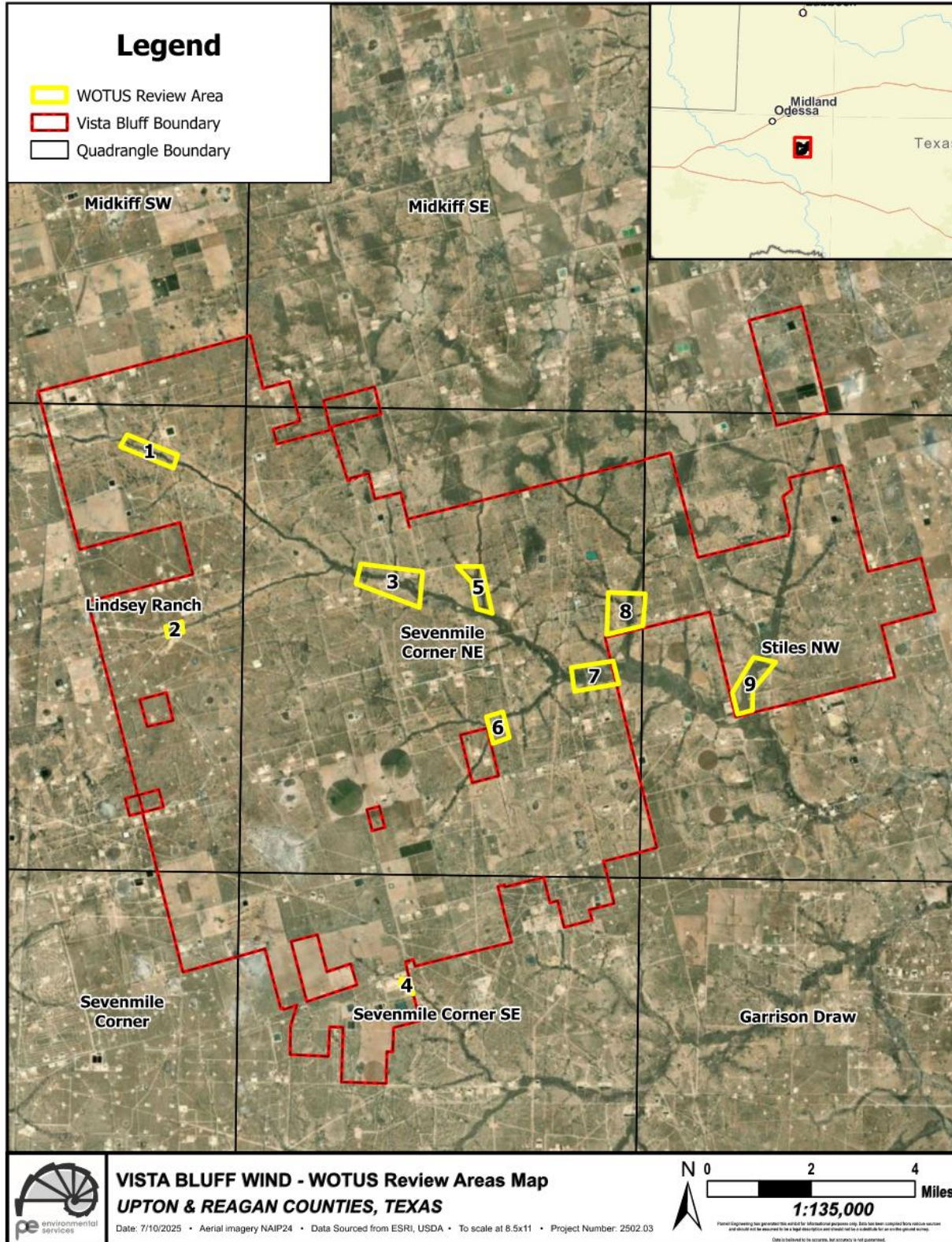




Figure 1B: Aerial Map

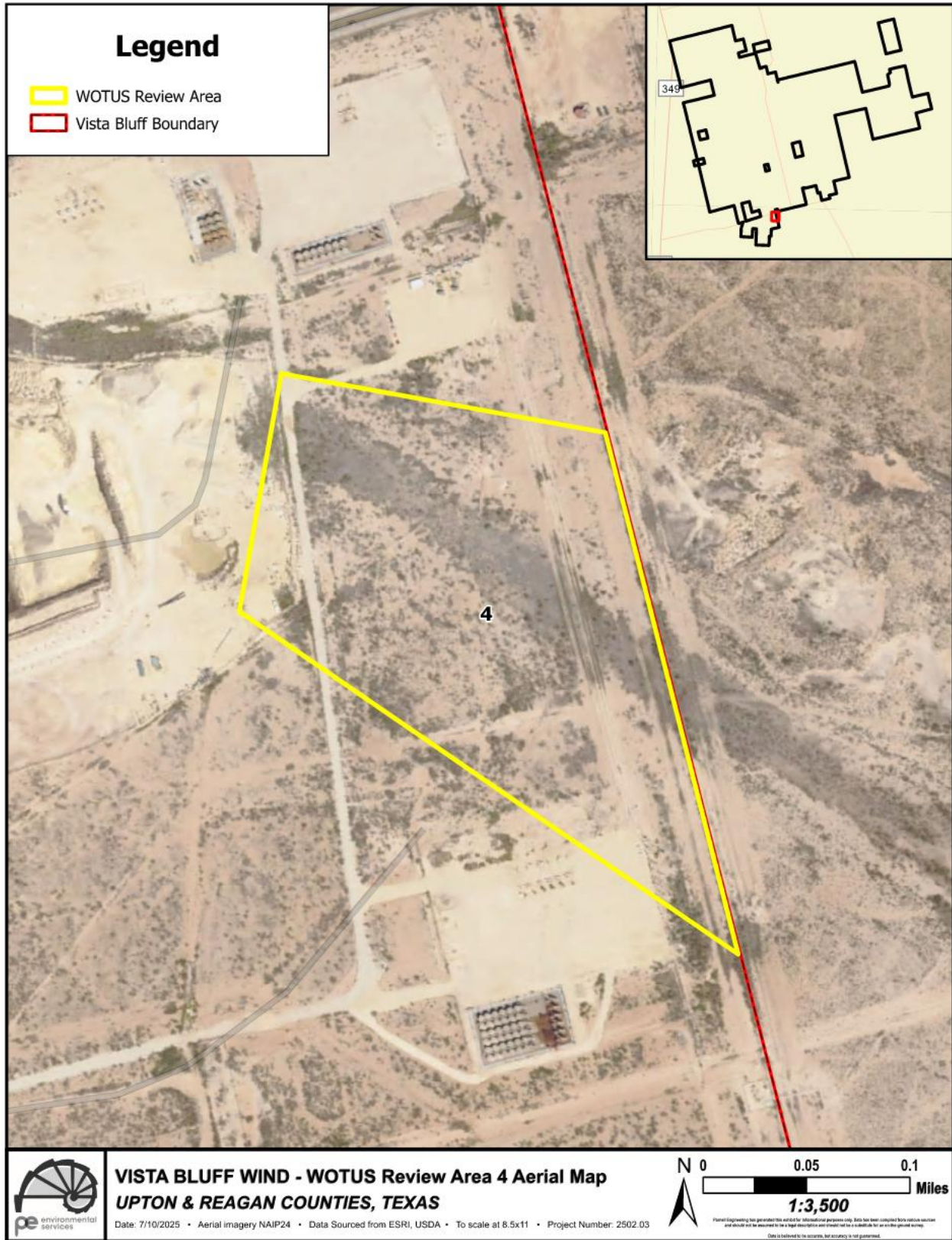




Figure 2: USGS Topographic Map

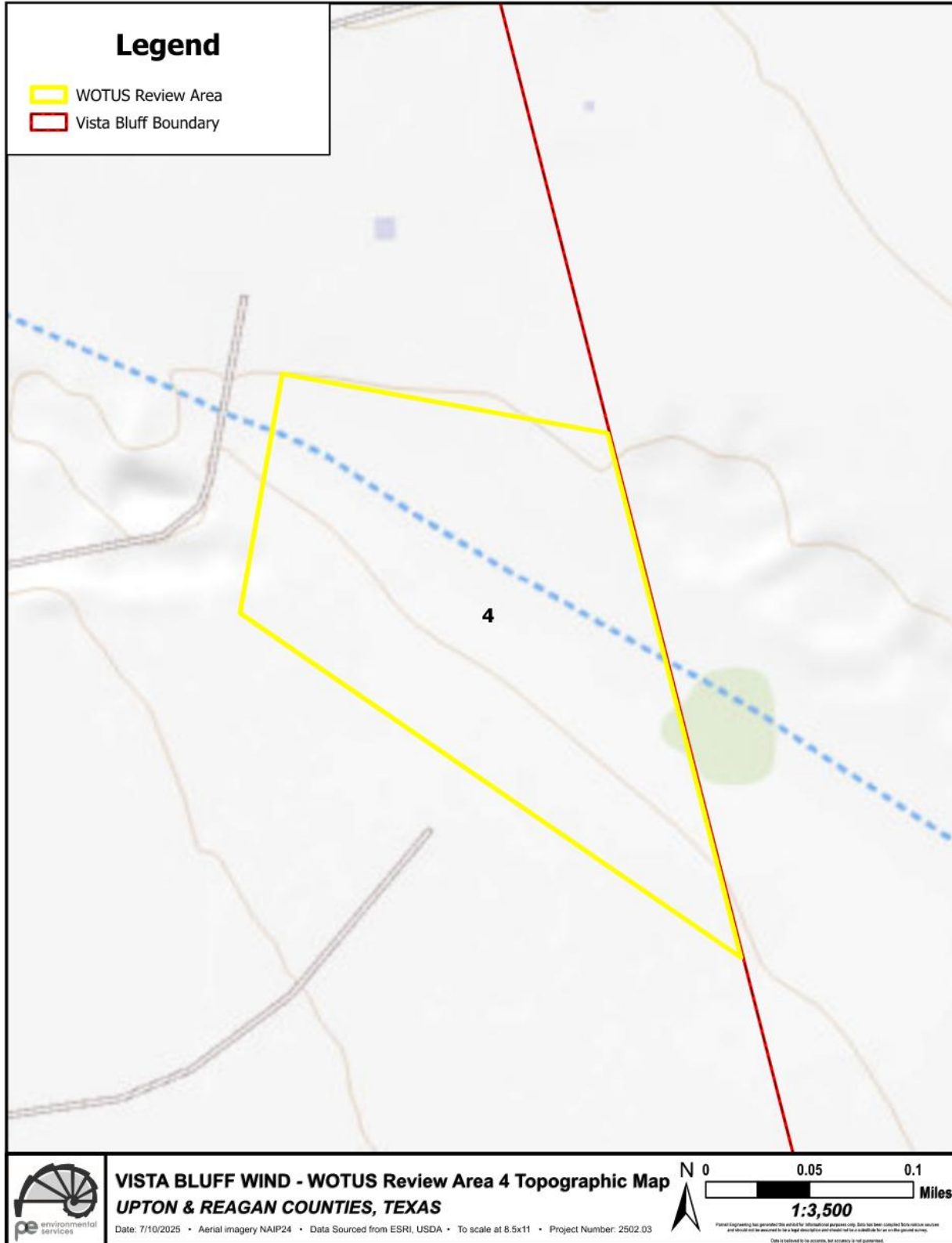




Figure 3: USDA Soil Survey

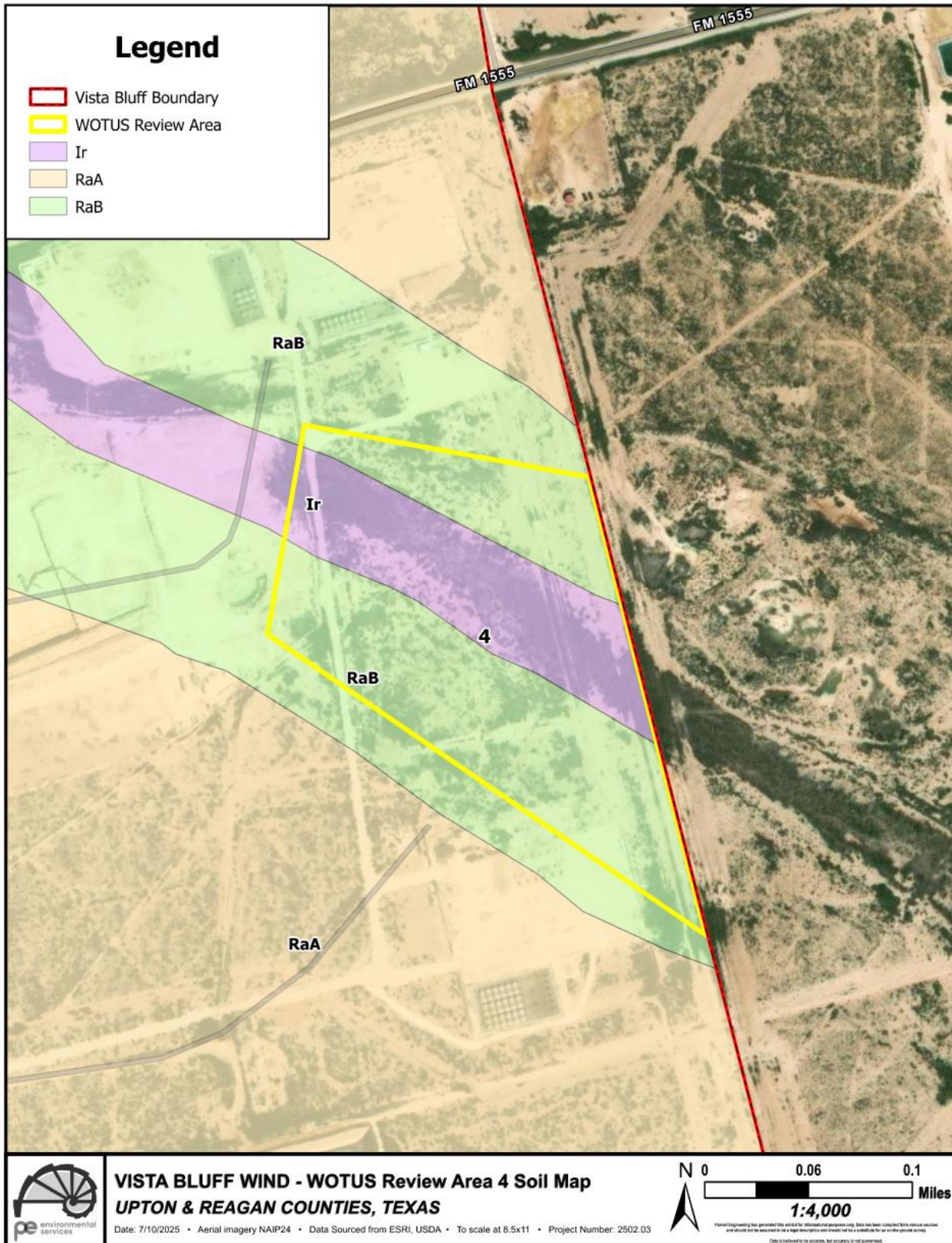




Figure 4: National Wetland Inventory

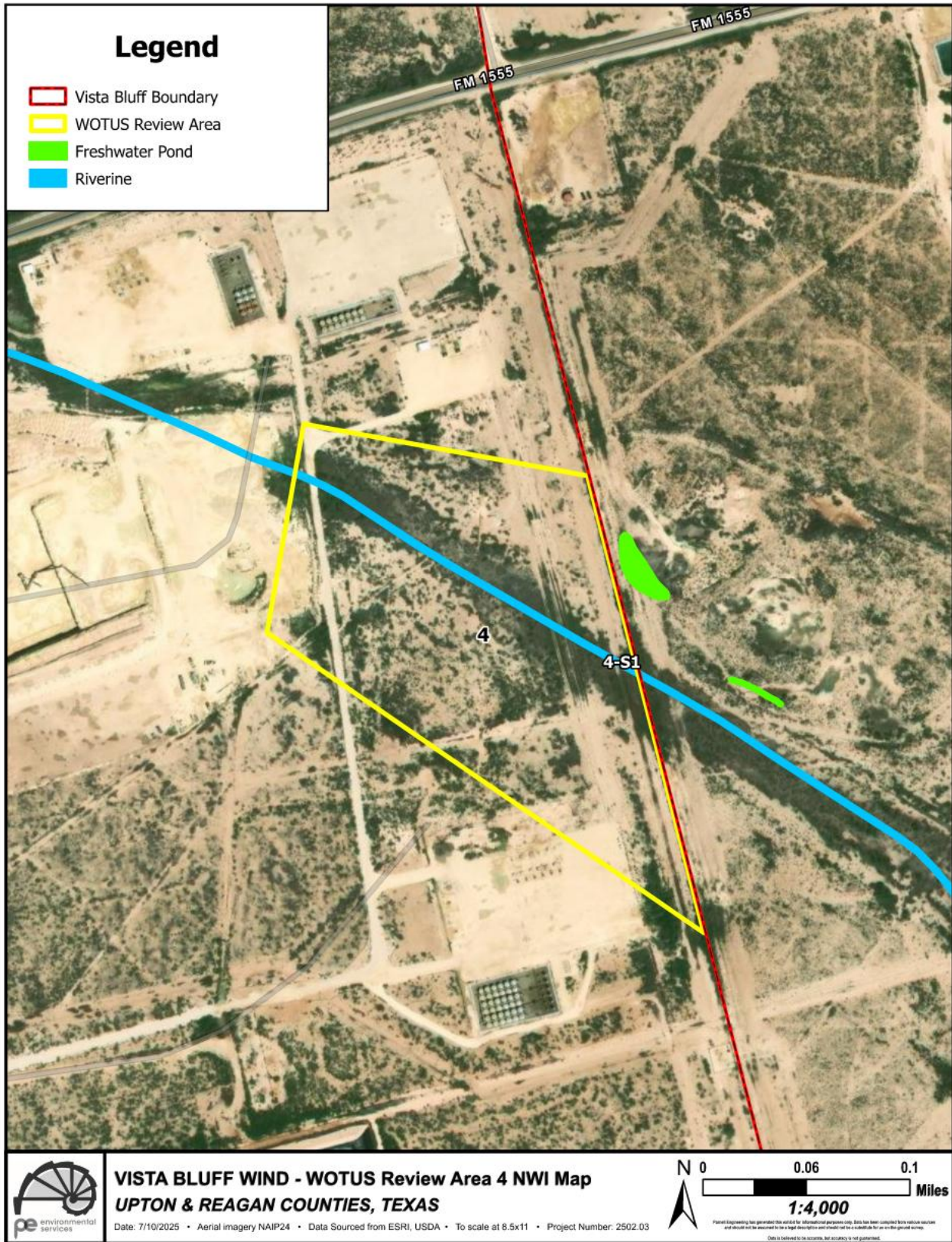




Figure 5: National Hydrography Dataset

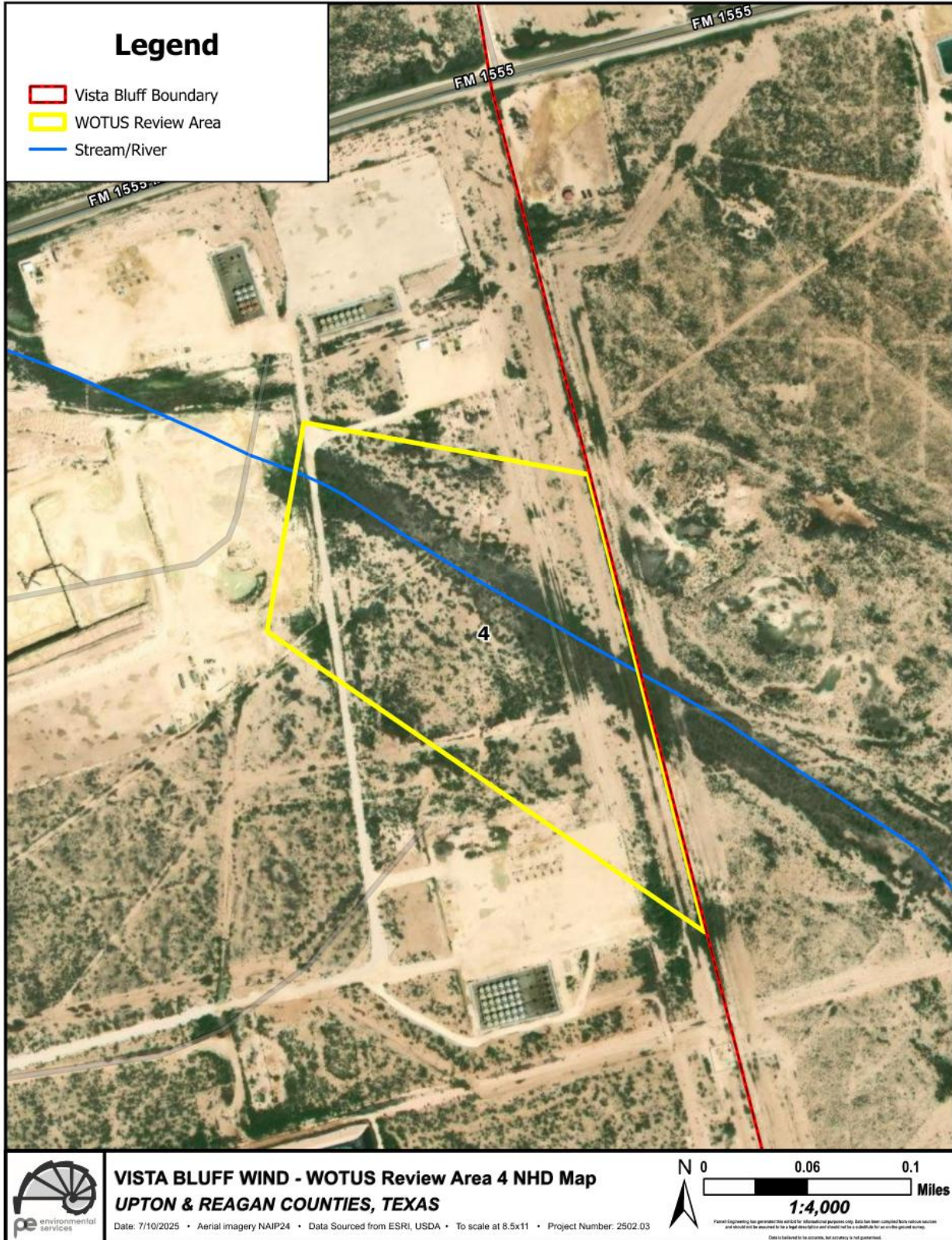
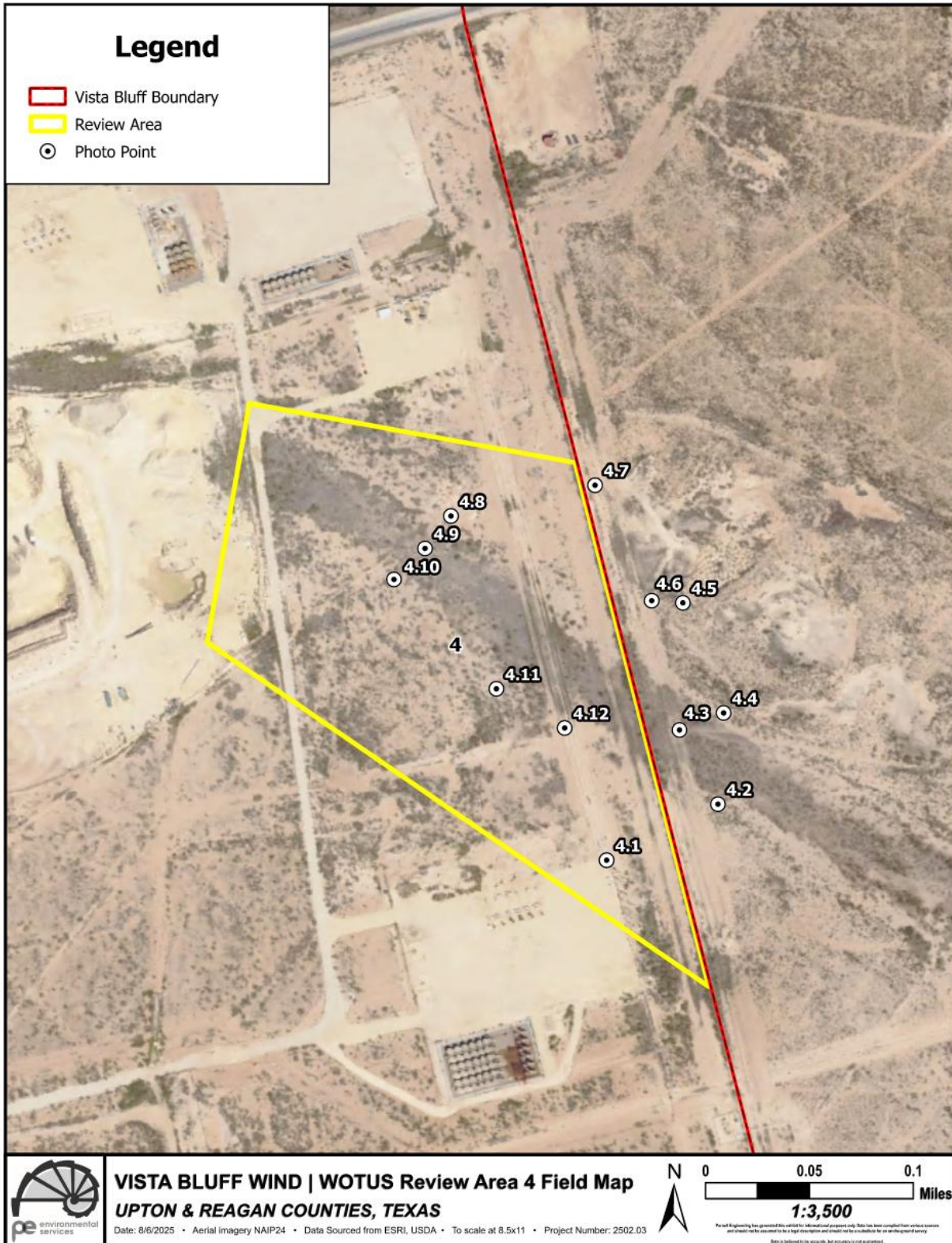




Figure 7: Field Map

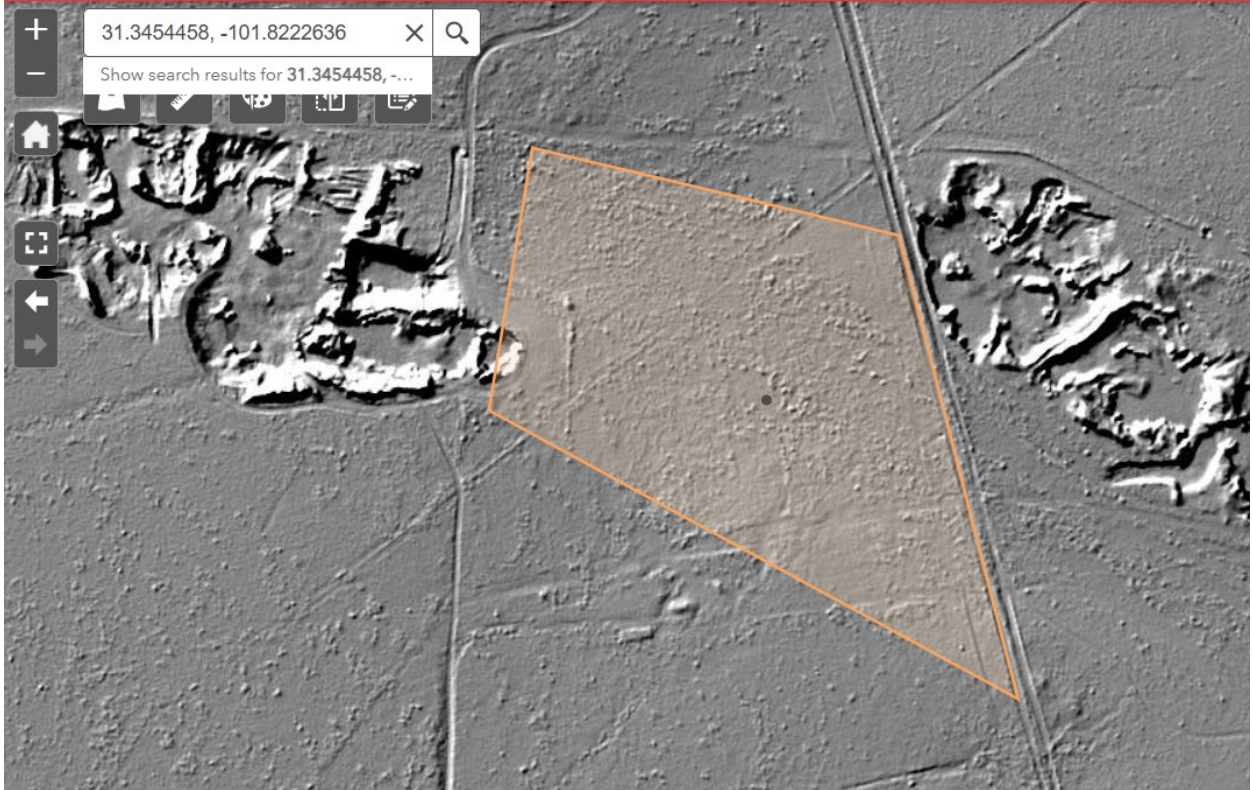
