Summarize overall biological, chemical and physical functions being performed:

Water, which flows through Tributary 2 enters Wetland 1. The Wetland provides biological functions as habitat for amphibians and invertebrates, as well as mammals. The vegetation detritus provides the basis of a food web that supports the wildlife community downstream. The water features provide for the nutrient and chemical uptake of the waters that percolate into the soils. This nutrient and chemical uptake provides for a reduced nutrient/chemical loading in the downstream water column. .

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The vegetation detritus provides the basis of a food web that supports the wildlife community downstream. These functions provide an indirect biological connection to the TNW. The tributaries and wetland provide for the nutrient and chemical uptake of waters that enter the stream and the waters that percolate into the soils. This nutrient and chemical uptake provides for a reduced nutrient/chemical loading in the downstream water column; providing an indirect chemical connection to a TNW. It is IES' professional opinion that Tributaries 1 and 2 and Wetland 1 would be considered waters of the United States as they provide an indirect biological, chemical, and hydrological connection to a TNW. Tributaries 1 and 2 and Wetland 1 would, therefore, be regulated under Section 404 of the CWA.

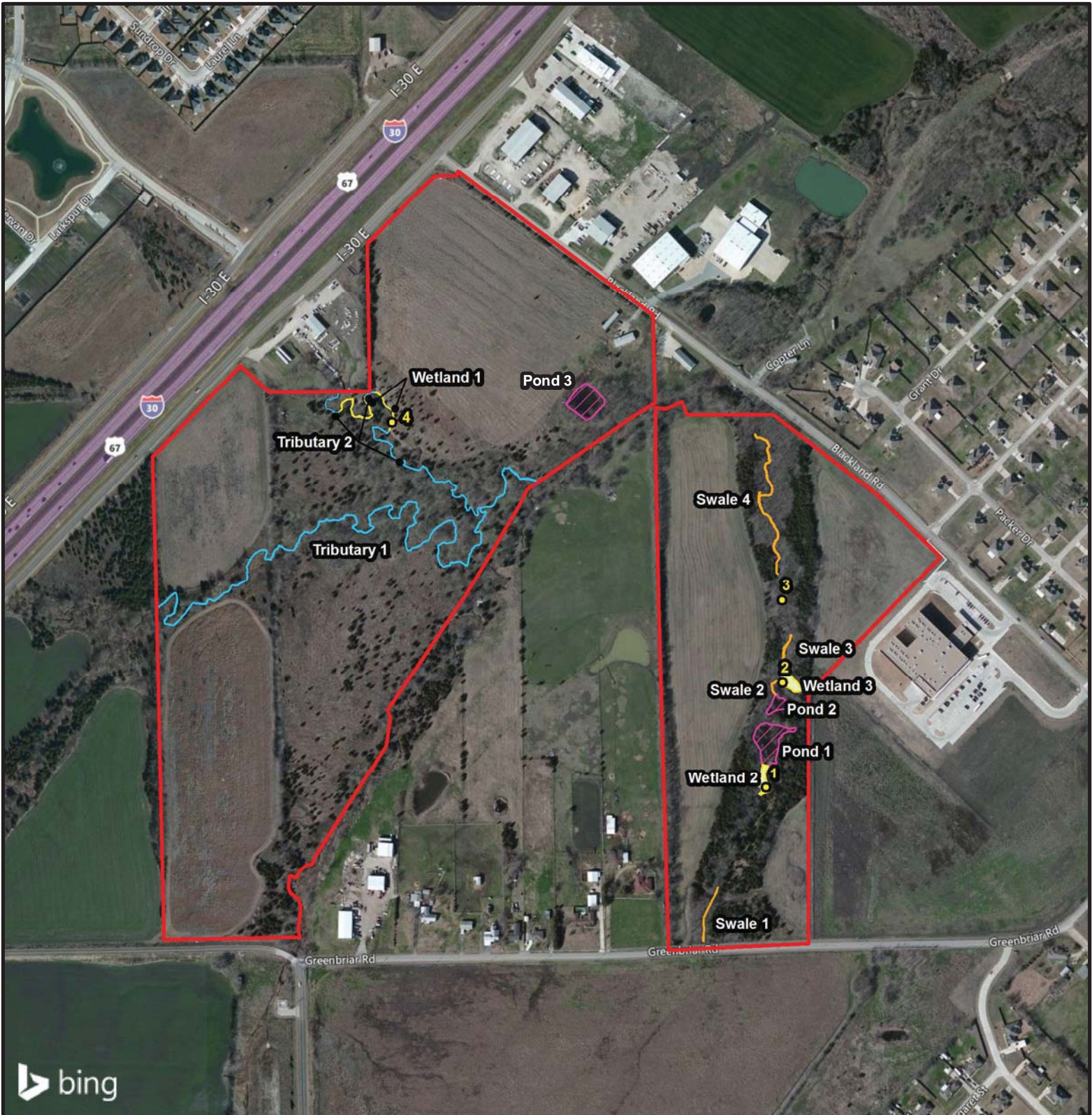
