This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Willow Creek (WW08); Little Willow Creek flows directly into Willow Creek; Willow Creek and Cottonwood Creek flow directly into Wilbarger Creek; Wilbarger Creek flows directly into the Colorado River (TNW); UCP01-02 and 07-10, and WET01 are located in floodplains connected to other onsite waterways which ultimately flow into the Colorado River, and thus, these upland cut ponds and this wetland are considered indirectly connected. The number of tributary connections before entering the Colorado River (TNW) range from 3-6.

Summarize overall biological, chemical and physical functions being performed: Some stormwater filtration/storage and wildlife support. Wetland appears to have been created in association with the excavation of UCP01. Overall, functional value is low due to influence of surrounding cropland and rangeland land uses.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
