C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on our desktop-based resource assessment and multiple site visits, we conclude that the project area is comprised entirely of dryland or upland. No wetlands are expected with site-specific occurrence of hydric soils, vegetation associated with saturated soils, and hydrology.

There are no “navigable waters of the U.S.” as defined under the Rivers and Harbors Act and there no “water of the U.S.” as defined under the Clean Water Act within the project-specific review area.
Attached technical memorandum contains detailed explanation on the rationale that the review area only includes dry lands or uplands.
