Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Seventeen separate AJD verification site visits were conducted by FNI environmental scientists and USACE Fort Worth District regulatory staff for the Project. Individual AJD verification site visits were conducted on: May 11, 2016; September 21 and 22, 2016; March 8 and 9, 2017; June 7, 2017; July 31 and August 1, 2017; March 7 and 8, 2018; March 21 and 22, 2018; May 16 and 17, 2018; May 23 and 24, 2018; June 5, 2018; June 6, 2018; June 13 and 14, 2018; October 25, 26, and 27, 2018; April 3, 2019; April 4, 2019; April 9, 2019; June 18 and 19, 2019. Site visit procedures typically included a pre-trip briefing on the properties and features to be visited, and then once on site(s), FNI and USACE personnel discussed conditions, jurisdictional statuses, and collected notes. FNI distributed follow-up spreadsheets to the USACE with specific notes about the water features visited and any updates made in the field. FNI personnel and USACE only verified WOTUS boundaries on properties where access was granted by the landowner.

In addition to site visits, two desktop AJD verification meetings were held on September 12, 2018 and August 21, 2019. During these meetings FNI and USACE personnel reviewed potentially non-jurisdictional features utilizing Bing and Google Earth imagery, including historic imagery, where available to determine whether the water features were isolated and/or lacked a downstream connection to WOTUS. This was done using a conservative approach where the preponderance of evidence indicated the features were non-jurisdictional, as such, features that were obscured from aerial view by cover (such as dense canopy) were assigned jurisdictional status. Water features that were verified by the USACE Fort Worth District are summarized in Appendix B of the Jurisdictional Determination Report.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This was done using a conservative approach where the preponderance of evidence indicated the features were non-jurisdictional, as such, features that were obscured from aerial view by cover (such as dense canopy) were assigned jurisdictional status. Water features that were verified by the USACE Fort Worth District are summarized in Appendix B of the Jurisdictional Determination Report.
