This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: The wetlands provide potential habitat for insects, crustaceans, amphibians, birds, small mammals and other wildlife, creating a highly productive natural community in an area of generally lower ecosystem function. Physically, they potentially provide functions such as flood flow alteration and sediment sequestration, limiting the extent and severity of future flooding events. They potentially perform chemical functions including water filtration and water quality improvement, as well as processing pollutants and organic wastes. Other potential functions include nutrient cycling and acting as carbon sinks.

To determine which wetlands were abutting to the tributary, we selected wetlands which used the tributary as one of its boundaries or which the tributary flows through. We used NWI maps to identify wetlands that were located outside of the subject property, but within the relevant reach of this tributary. Wetlands WET018, WET069, and WET072 all meet the criteria of having the tributary as one of its boundaries or the tributary flows through the wetland. All other wetlands were determined to be adjacent due to their location within the 100-year floodplain of the relevant reach of the tributary.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
