C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

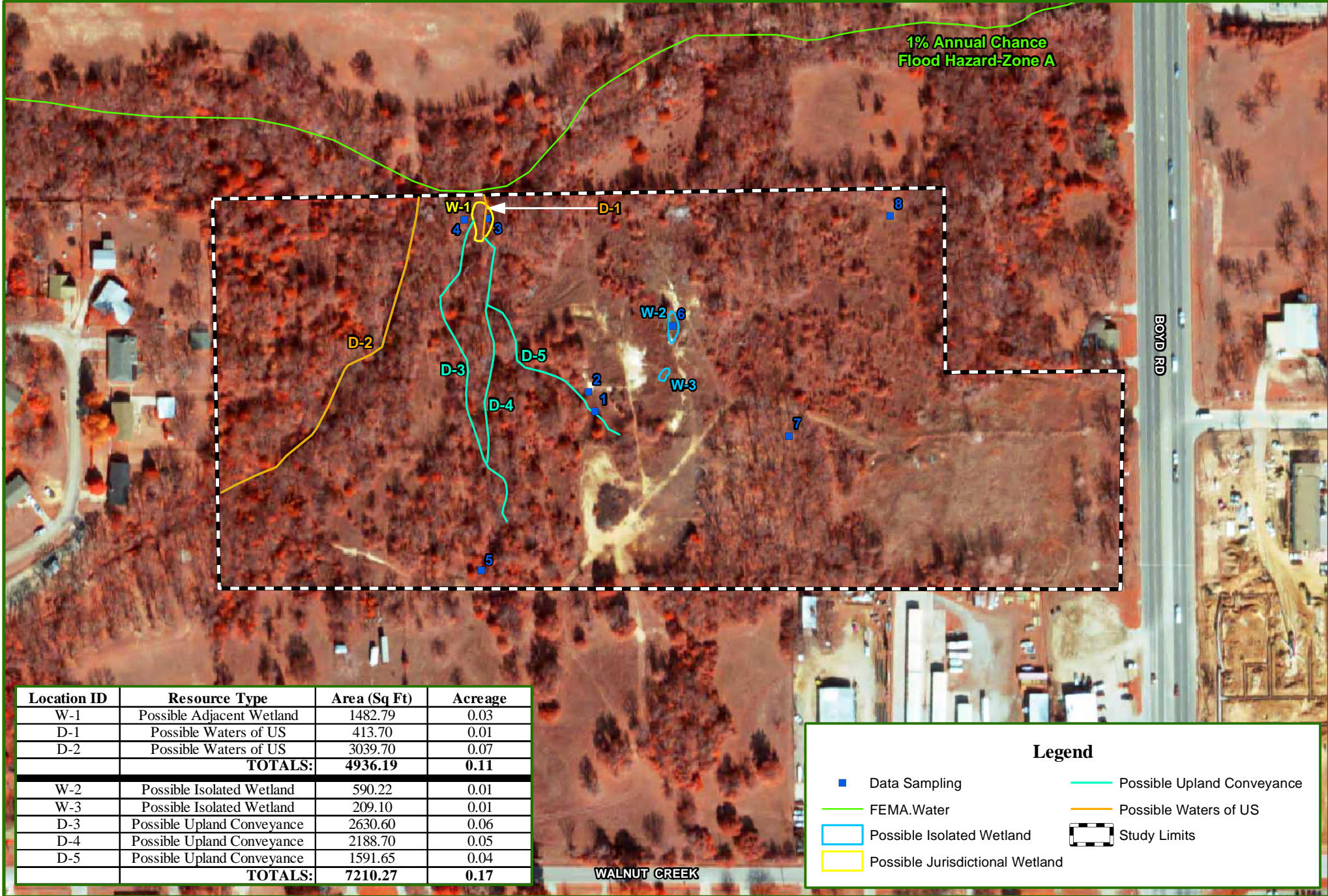

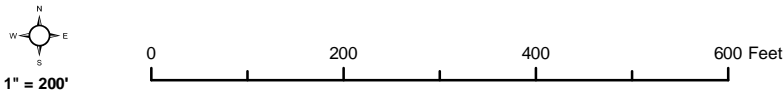
B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on the information provided and information available to the USACE, wetland W-1 and ephemeral streams D-1 and D-2 would be considered WOUS due to OHWM and characteristics of the stream segments and adjacency of the wetland to the RPW Walnut Creek. The swales D-3, D-4, and D-5 appear to carry only surface flows after rainfall events but do not exhibit any of the characteristics such as an OHWM which would be indicative of a WOUS. The isolated waters W-2 and W-3 appear to be limited discrete man-made excavations of sand and gravel materials, likely for local owner use only, not a commercial operation..

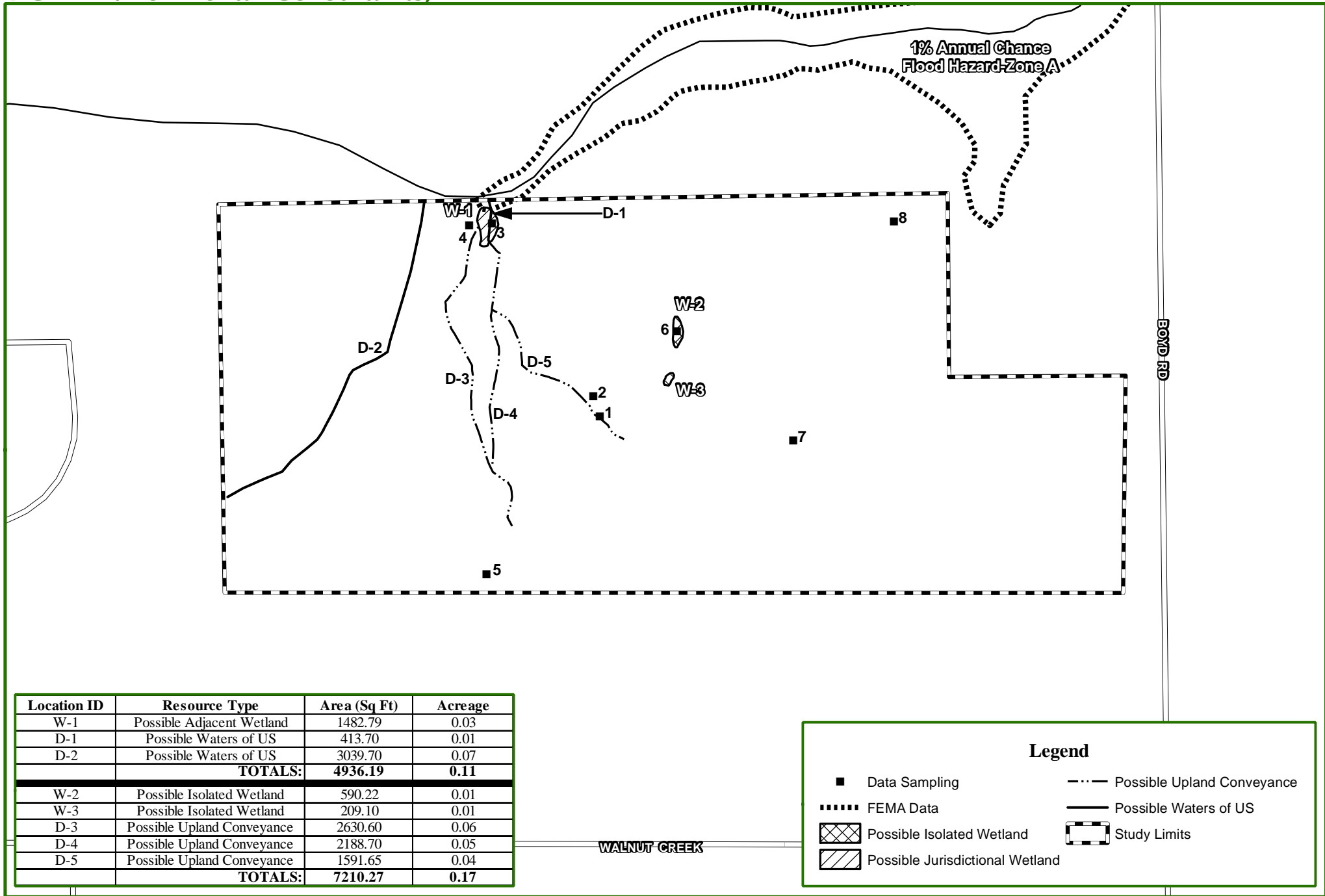

2015 Infrared Aerial Photograph

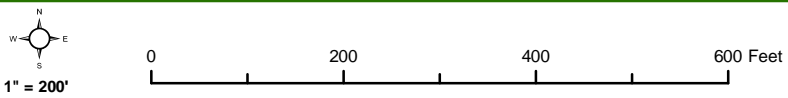

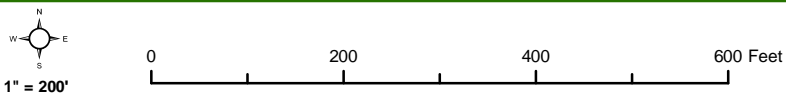
