**B. Typical year assessment(s):** No precipitation during the 24-hour period prior to and during the site visit. A total of 1.17 inches of precipitation was recorded during the 30-day period prior to the site visit. The Antecedent Precipitation Tool (APT) indicated that the conditions on-site at the time of the evaluation were considered hydrologically “normal” for 16 November 2020 based on the 30-year climactic average (32.87935, -96.981882).
