The study area contains two excavated ponds, one non-jurisdictional drainage feature, and one erosional depression feature within a drainage swale that are proposed for consideration as aquatic areas that do not meet the definitions of potential waters of the U.S. (i.e., nonjurisdictional).

Based on the information described herein and the results of HDR's study of available information, the features are most likely the result of previous excavation, agricultural activities and erosion in uplands consistent with changing land uses as the study area transitioned between agriculture, soil excavation, and undeveloped land uses surrounded by an urbanized area.

Based on historic aerial photo reviews back to the 1950s, no evidence of a stream channel or impoundment at either pond location is observed. Although more variable due to land use changes, review of historic aerials did not indicate a consistently defined OHWM was present in the location of NJ-D-1 and one was not observed during on-site inspection in March 2018.

The small erosional depression feature with wetland fringe is most likely the result of concentrated flow in a drainage swale during major run-off events that scoured recently deposited sediment, while the vegetation community succession has resulted in reduced overall run-off. The combined effects of the land use changes, along with excavation activities and erosion, have not been conducive to the development of an OHWM between the erosional depression feature, excavated ponds, or the non-jurisdictional drainage feature.

The locations of Excavated Pond Ex OW-1, Excavated Pond Ex OW-2, proposed Non- Jurisdictional Drainage Feature NJ-D-1, and erosional depression ED-1 are provided in the attached table Non-Jurisdictional Aquatic and Drainage Features and Proposed Jurisdictional Determination within the Timmermann Tracts, 80-acres, Travis County, Texas.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The study area contains two excavated ponds, one non-jurisdictional drainage feature, and one erosional depression feature within a drainage swale that are proposed for consideration as aquatic areas that do not meet the definitions of potential waters of the U.S. (i.e., nonjurisdictional). Based on the information described herein and the results of HDR's study of available information, the features are most likely the result of previous excavation, agricultural activities and erosion in uplands consistent with changing land uses as the study area transitioned between agriculture, soil excavation, and undeveloped land uses surrounded by an urbanized area.

Based on historic aerial photo reviews back to the 1950s, no evidence of a stream channel or impoundment at either pond location is observed. Although more variable due to land use changes, review of historic aerials did not indicate a consistently defined OHWM was present in the location of NJ-D-1 and one was not observed during on-site inspection in March 2018.

The small erosional depression feature with wetland fringe is most likely the result of concentrated flow in a drainage swale during major run-off events that scoured recently deposited sediment, while the vegetation community succession has resulted in reduced overall run-off. The combined effects of the land use changes, along with excavation activities and erosion, have not been conducive to the development of an OHWM between the erosional depression feature, excavated ponds, or the non-jurisdictional drainage feature.

The locations of Excavated Pond Ex OW-1, Excavated Pond Ex OW-2, proposed Non- Jurisdictional Drainage Feature NJ-D-1, and erosional depression ED-1 are provided in the attached table Non-Jurisdictional Aquatic and Drainage Features and Proposed Jurisdictional Determination within the Timmermann Tracts, 80-acres, Travis County, Texas.
