Both of the stock ponds appear to be located in uplands with no inflow or outflow channels. The nearest jurisdictional**

**water or waterbody, i.e. Peach Creek South Tributary 22.2, appears to initiate approximately 350 feet to the northeast of the nearest on-site stock pond (to the north of Dymple Lane). Both of the stock ponds are located outside of the 100-year floodplain.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The two (2) stock ponds are both located outside of the 100-year floodplain in uplands. There does not appear to be any inflow or outflow channels connecting to or directly abutting the stock ponds. Furthermore, an ordinary high water mark was not observed down-gradient of the stock ponds on the subject property. The nearest potential jurisdictional water, i.e. Peach Creek South Tributary 22.2, appears to initiate to the north of the subject property (slightly north of Dymple Lane). Due to the isolated nature of both stock ponds or impoundments, these areas would not be used in connection with interstate commerce.

The USGS topographic maps indicate that an intermittent "blue line" stream is located on the subject property down-gradient of the northerly-most stock pond. This presumptive aquatic resource was also identified on the United States Fish and Wildlife Service Wetland Inventory Map. However, an ordinary high water mark was not observed on the northerly portion of the subject property. Furthermore, wetland vegetation was not observed in this area.
