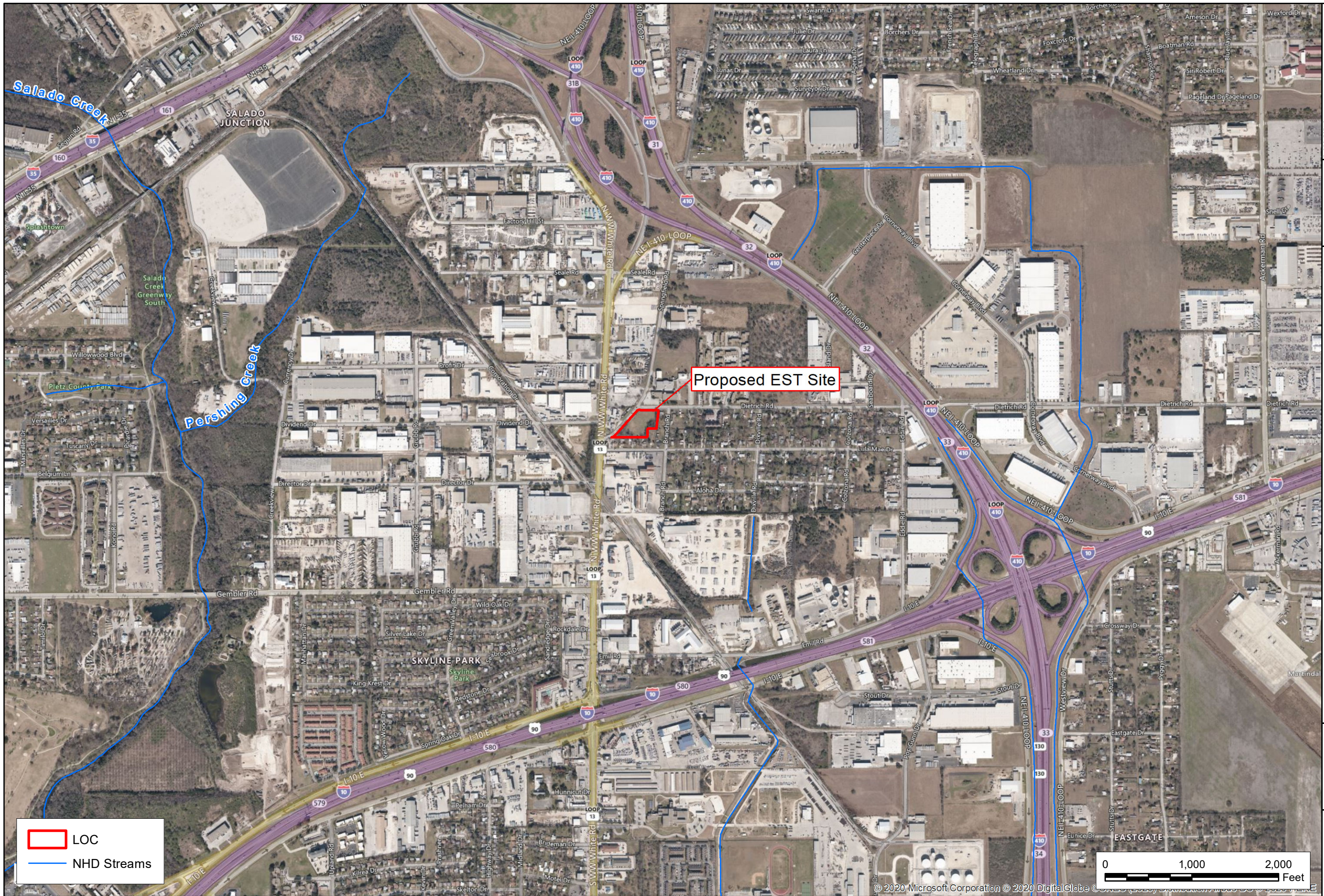

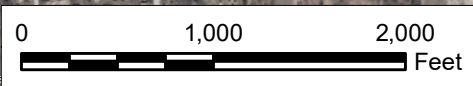

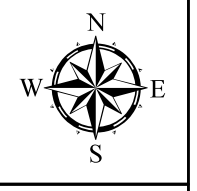


Proposed EST Site
