B. Typical year assessment(s): Data from the NRCS Agriculture Applied Climate Information System (AgACIS) was downloaded and reviewed using the Direct Antecedent Rainfall Evaluation Method (DAREM), accessed October 12, 2020. The DAREM provides an index of climatic conditions, as they pertain to wetland hydrology, for the time period in which field data was collected. Rainfall data was obtained from the Dallas FAA AP, Texas, weather station; the nearest weather station to the study area with the range of historic data available necessary to calculate the DAREM. According to the DAREM, the study area was experiencing wetter than normal hydrologic conditions at the time of the site investigation.
